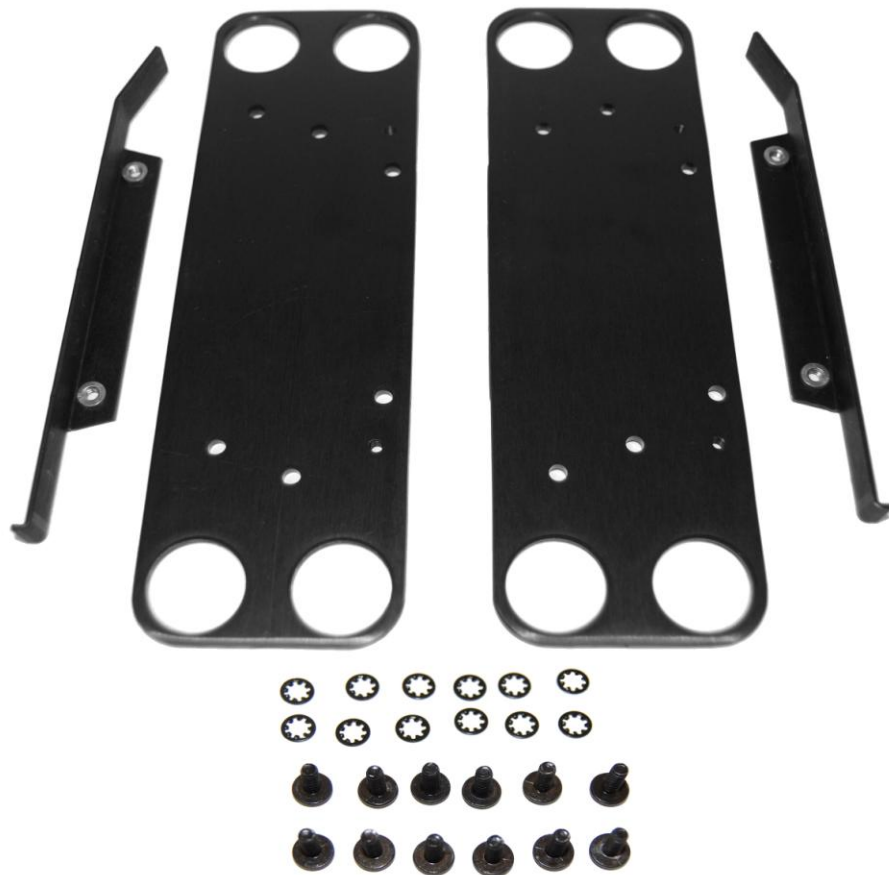

DESCRIPTION

The **PROK-1** is a unit protection kit designed for any NanoAmp™-sized enclosure. It consists of a set of side plates with attached side brackets. The side plates protect the front panel controls and the rear connectors from impact damage and provide attachment points for a shoulder strap (not included); the slide brackets allow easy quick change of remote power packs.

The **PROK-1** includes quick-change slides for the battery and converter modules. An attractive protective carrying bag with shoulder strap, Model ABAG-1, is available. The ABAG-1 is supplied with the **PROK-1** protection plates included.

PROK-1 Assembly Procedure

PARTS LIST:

2 ea. ATI # 20767 Side Protector Plate

8 ea. 6-32 x 3/8 truss head SS screws

INSTRUCTIONS:

1. Remove 8 ea. 6-32 x 1/4 truss head screws / washers that secure the mixer top and bottom covers. Retain 8 ea. internal tooth lock washers.
2. Secure 8 ea. 6-32 x 3/8 truss head screws (supplied). Align the Protector Side Plate with the top and bottom cover holes (4 ea) located on the side of the mixer.
3. Insert the 4 ea. 6-32 x 3/8 truss head screws (supplied) and the washers, attaching the Protector Side Plates to the mixer.
4. Repeat the above on the opposite side. Installed correctly, the Plates will protrude beyond the base of the mixer.

One Year Limited Warranty

ATI warrants this product to be free from defects in materials and workmanship to its original owner for a period of one year from date of purchase. ATI will repair or replace such product or part thereof, which upon inspection by ATI, is found to be defective in materials or workmanship.

The Proper Return Authorization Number must be obtained from ATI in advance of return. Contact ATI at 856-626-3480 or email sales@atiaudio.com to receive the number and instructions for return of your unit.

A written statement providing the name, address, daytime telephone number and email address of the original owner, together with receipt from the original purchase, and a brief description of any claimed defects, must accompany all returns. Parts or product for which replacement is made shall become the property of ATI.

The customer shall be responsible for costs of transportation and insurance to the factory of ATI, and shall be required to prepay such costs.

ATI shall use reasonable efforts to repair or replace any product covered by this limited warranty within thirty days of receipt. In the event repair or replacement shall require more than thirty days, ATI shall notify the customer accordingly. ATI reserves the right to replace any product that has been discontinued from its product line with a new product of comparable value and function.

This warranty shall be void in the event a covered product has been damaged, or failure is caused by or attributable to acts of God, abuse, accident, misuse, improper or abnormal usage, failure to follow instructions, improper installation or maintenance, alteration, or lightning, power fluctuations and other incidental or environmental conditions.
